3. Presentation and Discussion on New NWCCU Standards

Kevin McCarthy updated the team on the accreditation work and the New Standards from Northwest Commission on Colleges and Universities (NWCCU) that RTC will be using for the upcoming 2021 site visit. Originally we focused on the "old" standards as it was an option available and now we learned that the "new" standards are recommended by the NWCCU. There was a lot of overlap with the "old" to the "new" standards so our work did not go to waste. The new standards focus is on Student Success and heavy on data support. The positive is that now there is only 2 standards vs 5.

With this we are looking at the core accreditation team, Jichul Kim had been filling as the Accreditation Liaison Officer (ALO) and that will be transferred to Stephanie Delaney and Jichul Kim will be focusing on supporting the data side of the accreditation. Sarah Wakefield will be tasked on the writing portion of the accreditation (one voice narrative).

Kevin McCarthy thanked the College Council members for all the worked done on accreditation. Accreditation is important not because NWCCU is coming but for us as an institution to check ourselves and what we are doing is helping the student succeed and can back it up with data.
