JK – Discussion about meeting NWCCU standards and the RTC Strategic Plan. NWCCU has rubrics we will use to understand their expectations. Key Perfomance Indicators (KPIs) and Strategic Indicators (SI) are our evidence that we are meeting their standards (telling our story and showing where we are). Reviewing bencharks means we have to understand KPIs, Strategic Theme, Strategic Theme Objective and our Mission. NWCCU expects us to fulfill our mission. How do we prove we are fulfilling our mission? We have a strategic theme with objectives and then to measure the themes and objectives we have KPIs. KPIs meet their expectations. RTC now has a revised mission statement and a 5-year plan (2017-2022). During this, we shifted from core themes to strategic goals for assessing our progress to our mission fulfillment. Now that we are focused on strategic goals, we created strategic indicators (too many of them). Our strategic themes are aligned with strategic goals.

CR – Do our KPIs adequately cover what NWCCU will be looking at for mission fulfillment? JK – Yes, but we need to see if those 22 KPIs meet our current goals.

CR – What is the advantage to going with the 52 SI?

JK – SI are more sophisticated but we aren't sure they are really balanced and meaningful.

CT – Do all SI cover the KPIs?

JK – We need to make sure that the KPIs cover what we want to assess. This governance body has the power to choose the direction. In the monitoring report, you will see a strategic scorecard.

Reviewing benchmark: activity 1 – break up into smaller groups to do ranking of standards. We may all review Standard One together and then break up into smaller groups.

KH – We are looking to find out where we are, not how to fix it right now.

PL – We are looking for evidence that will fulfill their expectations and our mission.
